Fund Overview

CompAM Active Global Equity is an effective solution for investors looking to gain exposure to world equity markets. Most of the assets will be invested in short-dated bonds issued by governments of the Eurozone and certain supranational issuers and gaining exposure to Global Equities using index futures traded in derivative exchanges domiciled in developed countries. Currency exposure will be towards the Euro. Compass Asset Management has over 15 years of experience in global asset allocation.

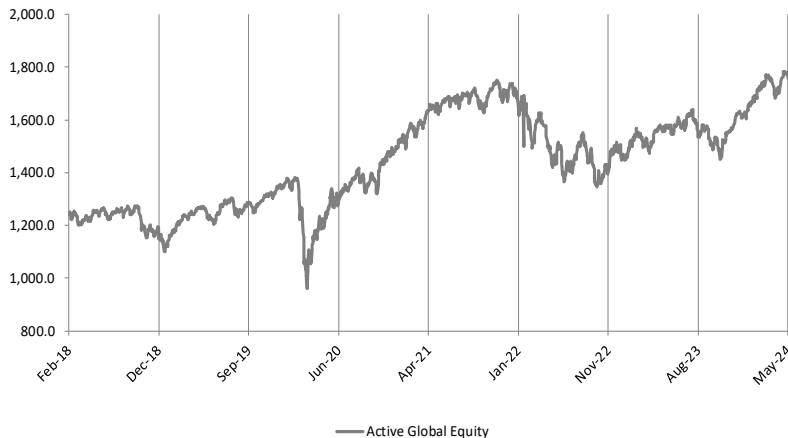
Investment Strategy

The Sub-Fund aims to obtain long-term gains and will seek to have exposure to global developed market equities that will range between 95% and 100% of its net assets by using financial derivative instruments listed in regulated markets domiciled in developed countries.

The main part of the net assets will be invested in bonds issued by governments of the Euro Zone member countries, the European Union or the European investment Bank with residual maturity up to twenty-four (24) months.
